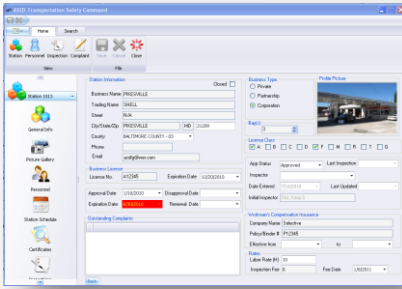
CapWIN Releases Mobile Client Version 2.2.4

CapWIN is pleased to announce that we recently unveiled an updated version of our Mobile Client. Additional data sources are now being made available to CJIS users. These include Maryland Parole & Probation and Maryland District Court Statewide Warrants. These new data sources have the potential to increase the volume of information returned for all law enforcement agencies when running a query, so a filter panel has also been incorporated. The filtering option organizes returns based on their source (NCIC, NLETS, MVA) and the results from a specific source may be displayed by clicking on the highlighted name. We have also added a “copy to clipboard” button that provides a mechanism for copying query returns and pasting into a word processing program. Our Maryland law enforcement agencies will also notice a new VPO tab, which allows for the updating of Protective Orders on the Maryland State system. We welcome any feedback from our users on these new features.

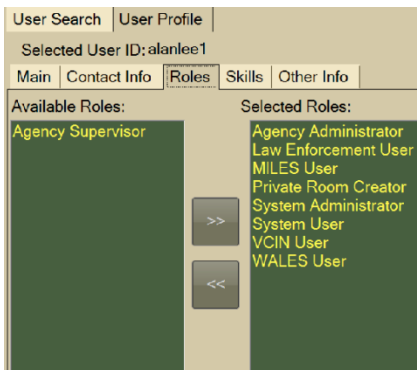

CapWIN Partners with MSP to Enhance Automotive Safety

CapWIN is currently assisting the Maryland State Police's Automotive Safety Enforcement Division (ASED). We are enhancing their operations to include the automation of ASED's business processes as they relate to Maryland Inspection Stations. The new system will provide ASED Inspectors the ability to conduct site reviews and document their findings while in the field. Our design work will also include the development of a Safety Equipment Repair Orders (SERO) module of Delta Plus.



CapWIN Provides Agencies new Private Chat Room Options

As a reminder to all agencies, changes have been made regarding who may now create Private Chat Rooms. In order for a user to have the ability to create a "private" chat room that user must have previously been granted the Role of **Private Room Creator** as part of their user profile. This feature was created in order to provide individual agencies greater flexibility in determining if they wish to grant users the privilege of functioning in "non-public" rooms. User roles are granted and monitored by individual agency administrators.
